


















LONG BEACH SWAP MEET Sat. July 20th



Just a few notes on this year's annual Long Beach Swap meet. Actually the 70th annual, and may be the longest running annual antique car swap meet in the U.S.. I have a soft spot for the Long Beach meet Been going there for over 60 years and picked up some memorable stuff there. I've only missed a few over the years and have lots of friends down there. I departed home heading for Long Beach at an uncomfortable 3 AM Saturday morning and due to 3 major traffic jams, the first one on I 5 just before reaching Los Angeles, then one on I 210, and one on I 605 (first two CalTrans, working on the highway, four lanes reduced to one, and the third was a big accident on the north bound lanes and the looky loos heading south caused the jam. So I didn't get to the swap meet until 9:30 AM. The organizing club Long Beach Model T Club always has a nice display of members cars there for show as you enter the meet. \$5.00 entry fee for buyers. They claimed over 200 vFor Sale Six New tires mounted on TT Demountable Wheels, These Tires are Universal 450 /475 -21 in size. They are a couple of years old but have never been mounted on the car and have zero miles on them . At today's pricing Six Tires and tubes shipped to your house would be about \$ 1040.00 .I am asking 650.00 For the tires and tubes,

The wheels are Free! Please call Ben at 510 427 0482 endors, but I doubt that. Anyway, I'm glad I went. Always a good meet with plenty of Model T and Model A parts, a few street rod vendors, a few tool vendors and some with just miscellaneous goods. Overall, from my viewpoint, there was a lacking of buyers. Same as this years, Auburn and Bakersfield meets. I really didn't need any T parts but was hoping to find some brand X (Chevrolet etc.) stuff. I did have a couple of requests from friends and family for me to lookout for a couple of T things. My grandson Chris said that he needed a couple of tires. I recommended Lucas produced, Wards Riversides as they look the most authentic, size wise, and as I told him it really doesn't matter which brand that you get as none of the new tires wear well due to the type of rubber all the tire companies are using. A short time later he reported back that Lucas is out of stock on them. I told him to hold off because I'm going to the Long Beach swap meet and I might find something there. Well, as luck would have it I did find a couple, mounted on some old wheels, the tires were old originals made/sold by Montgomery Wards some 45 or so years ago and were age cracked, but not real bad. I was going to ask the price but the vendor wasn't at his booth. So made a mental note to come back and check. Continuing on some distance, there was five NOS Riversides mounted on Hayes demountable rims, and absolutely no age cracks. Vendor wasn't there either, so I moved on, keeping an eye on that space as I continued to look and finally spotted somebody, and went back to inquire. He said \$1000.00. Ouch! We did some heavy negotiating and I brought them home. Unfortunately by then, 10:30 AM some guys were already starting to pack up and leave, so I rushed through, finding nothing else to buy, but did see a few Warford transmissions, a Muncie, a couple of Frontenac heads, Ruckstell rear axles, outside brakes, various size wire wheels, and loads of stock chassis parts. Just before I left I stumbled on to none other than Jim Lukash with a large bag full of stuff that he bought and happy as if he had good sense. I was out of there by noon. A couple more traffic jams enroute got me home by dinnertime 6:30 PM. I sure hate to see a low turnout of buyers because that means a few less sellers next time, because nobodies buying. And sooner or later no swap meets at all, and we're back to the way it was back in the 1950s with no place to get parts when you need them. So, getting on my soap box a little. Support the swap meets that are apt to have lots of early car stuff, not just street rod stuff. Getting original parts even if they're worn some, is so much better than any of the repro garbage sold by the parts houses today.

Selling a car, parts, or parts wanted; INTERNET SCAMS

As an automobile appraiser, I've always stayed away from brokering cars for clients as I never liked mixing appraising and buying and selling. Well for a variety of reasons that I won't go into here, that has changed in the last year or so. This story is not an attempt to publicize any of that it's an attempt to make you aware of some of the scamming that's going on with our great "electronic world". As most of you know scamming is prevalent in our society. The following is only what I've encountered, mainly in my brokering business, mostly done electronically. Let's start with selling a car or parts. You run an ad that gets read electronically which goes out to hundreds of thousands of people and you receive responses via email or other electronic method. "I'll buy it!" "I'm happy with the price" "Tell me more about it, please send pictures, what's your lowest price?" I always include as many pictures as possible a good description and an asking price in my ads, so some of those comments are the first clue. There's a variety of their verbiage that will give you a hint. Words like calling what you're trying to sell "the item". "Is the item still for sale?" "Kindly" "Kindly get back to me with your final asking price and some photos of it. let me know" "I await your reply" "I'm fine with the asking price" These are actual quotes from scammers. They're going to send a Cashiers Check, or a variety of other bank checks, samples are seen below. They are flawless appearing checks and often made out for more than your asking price. Sometimes they explain "the extra is for you to pay the shipper" or "I mistakenly made it out for more kindly return the excess to me" These are just a few examples. They're all a little different. I begin by treating them all like they're real. I try to respond politely but usually in my second response I let them know that I already have some bad checks, So figure out a different way of payment. I won't accept your check. My bank charges me for processing bad checks, please call me 510 581 4911 and we'll discuss the car and possible methods of payment. That usually ends it right there. No one has ever called, although some have continued to attempt to proceed via email with various real sounding responses. "My check will be good and when you have the cash I'll have my shipper pick the car up." I've taken the checks to the bank and have the manager comment that they're no good, early on I deposited a couple, just to be sure, because the "buyer" seems so sincere. My attitude is, even though you have suspicion that it's a scam treat it as sincere as possible until it fizzles. And they're all a little different verbiage but usually some of the words used are the same. Most of these have come from my ads on the Horseless Carriage Club of America on line classifieds. That doesn't mean that you shouldn't advertise there, it's a good source. Just be aware. I hope some of this helps some of you.

.. Now, moving on. You have a want ad describing a part that you're looking for and you receive a response. "I have one" sometimes they describe the condition and price. There's only one absolute necessary response to that. "Please send me a picture" If you want even more positive proof, "Please send me a picture of the part, with you holding it". That ends it, that's the last you hear from them. I got caught by one of those a few years ago and lost a few hundred dollars. Lesson learned. You may have some of your own to add to these, don't hesitate to share them
